STAYING COVID-19 SECURE IN 2020

We comply with the Government's guidance on managing the risk of Covid-19

We have carried out a full Covid-19 risk assessment.

We have cleaning, handwashing and hygiene procedures in line with guidance.

We have taken all reasonable steps to work with our House team members to ensure they work safe. All team members are aware of our risk assessment and have undertaken "Covid-19 Return to Work" protocol training, all including everything listed here.

We are doing our best to maintain a 2metres distance in our Houses, where people cannot be 2metres apart, we are trying to do everything possible to manage transmission risk.

We will ask all customers to register with our team members, these details will be kept confidential and will be destroyed after 21 days.

DURING THESE EXTRAORDINARY TIMES PLEASE COMPLY & UNDERSTAND THE FOLLOWING CONDITIONS WE HAVE IMPLEMENTED TO OPERATE OUR HOUSES :

- If you or a member of your household are displaying symptoms of Covid-19 please do not enter.
- Respect social distancing and all directional signage in our Houses.
- Queue as directed, no queuing inside.
- Follow our "One Way" & "Give Way" signage.
- Use the hand sanitiser stations at our House entrances and toilets as provided.
- Understand our capacity may change based upon demand and the weather.
- In the event of rain, customers cannot come inside if safe capacity guidelines don't allow.
- Designate one person in your party to go to the bar to order. We are mandating only 3 people, from different parties, at the bar at one time.
- Once the drinks are dispensed, please leave the bar area promptly.
- No vertical drinking or eating is allowed inside.
- We prefer you use contactless payment methods.
- Use the food pick-up table to collect ordered food items.
- Use dirty dish and dirty glass tables as needed, we will only clean empties when your table is vacated.
- Do not move furniture around.
- Do not use seats and tables that are designated "Not in Use".
- A maximum customer table/party size will be 6 people if they come from different households.
- A maximum customer table/party size will be 8 people if they come from two different households only.
- Children must be supervised at all times, supervising parents and adults must ensure children respect social distancing guidelines.
- Dogs must be on a lead at all times.
- Police and licensing officers can visit our Houses at any time, please co-operate with them fully.

ANYONE WHO DOES NOT COMPLY WITH THE ABOVE WILL BE ASKED TO LEAVE.
